Avnet US Sales Tax Policy

Avnet, Inc. is registered to sell and ship product in almost every state which imposes a sales tax. With registration comes the responsibility for Avnet to charge and collect sales tax on all sales unless our customer claims an exemption AND provide valid sales tax exemption documentation. The appropriate documentation can be a state resale or exemption certificate or additional documentation as required by each state. Please read the requirements below and contact us with any specific questions you may have.

- As a seller, Avnet is required to retain valid sales tax exemption documentation from our sold to customer who claims sales tax exemption. Customers who ship product to their own location will need to provide exempt documentation for each state in which they claim an exemption or will be charged sales tax when Avnet has not received supporting exempt documentation.
- Sales tax is not imposed in the following states: **Alaska, Delaware, Montana, New Hampshire, and Oregon**. Shipments into these states will not have sales tax applied as the state does not have a sales tax.
- Avnet is not registered in Hawaii. Shipments into Hawaii will not have sales tax applied.
- Sold to customers must be registered in **Connecticut, Maryland and Washington D.C.** to claim exemption for any shipments to those states, including third party drop shipments. Customers cannot use a resale certificate from its home state or an end user resale or exemption certificate to exempt the sale. Customers must provide a state exemption number on a state or multi-jurisdiction certificate in order to claim sales tax exemption or will be charged sales tax.
- Avnet may be able to exempt sales into the following states based on certain state specific requirements, such as a Streamline or state form completed as a reseller or a non-resident: **Alabama, Arizona, Arkansas, Colorado, Florida, Georgia, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Michigan, Minnesota, Missouri, Nebraska, Nevada, New Jersey, New Mexico, New York, North Carolina, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virginia, Washington, West Virginia, Wisconsin, and Wyoming**.
- **California, Massachusetts and Mississippi** will allow Avnet to accept exemption certificates from parties to the sale other than our customer. We can accept the end user's exemption if they are a sales tax exempt entity, or another reseller's exemption certificate where applicable.
- Avnet International (Canada) Ltd. is a separate corporation with its own unique tax policy.
